An Ordinance of the City of East Wenatchee repealing Ordinance 2016-17 in its entirety.

2. Recitals.

- 2.1. The City of East Wenatchee (“City”) is a non-charter code City duly incorporated and operating under the laws of the State of Washington; and
- 2.2. On October 10, 2016, the City Council of East Wenatchee (“City Council”) and the Douglas County Board of County Commissioners (County Commissioners) held a public workshop to review the record of the planning commissions’ public hearing regarding proposed East Wenatchee Municipal Code amendments to establish a Loop Trail Overlay District.
- 2.3. On October 10, 2016, the City Council and the County Commissioners held a public hearing to consider the planning commissions’ recommendation and accept public testimony regarding the proposed East Wenatchee Municipal Code amendments. The Loop Trail Overlay District ordinances adopted by the City Council and County Commissioners were not consistent with regards to the treatment of fences.
- 2.4. The City Council finds that it is in the best interests of the City and its citizens to repeal Ordinance 2016-17 which adopted the Loop Trail Overlay District.


- 3. Authority.** RCW 35A.11.020 and RCW 35A.12.190 authorize the City Council to adopt ordinances of all kinds to regulate its municipal affairs and appropriate to the good government of the City.

THE CITY COUNCIL OF THE CITY OF EAST WENATCHEE DO ORDAIN AS FOLLOWS:

4. **Repeal.** The City Council hereby repeals Ordinance 2016-17.
5. **Severability.** If a court of competent jurisdiction declares any provision in this Ordinance to be contrary to law, such declaration shall not affect the validity of the other provisions of this Ordinance.
6. **Publication.** The City Council directs the City Clerk to publish a summary of this Ordinance. The summary shall consist of the title of this Ordinance. The City Council directs the City Clerk to publish a copy of this Ordinance on the City's website.
7. **Effective Date.** This Ordinance becomes effective five days after the date its summary is published.


